THREE INDICTED FOR HOME BURGLARIES



A Delaware County Grand Jury has returned a nine-count indictment against three Columbus residents for their roles in multiple home burglaries.

DELAWARE WOMAN CHARGED WITH AGGRAVATED VEHICULAR ASSAULT



A Delaware County Grand Jury has returned a four-count indictment against 37-year-old Misty Moore.

Charges come after the Ohio State Highway Patrol responded to the scene of an accident the morning of February 4, 2015.

"The accident happened just before 7 a.m. on Hyatts Road in Liberty Township," said Delaware County Prosecutor Carol O'Brien. "On scene

M. Moore Township, said Delaware County Prosecutor Caroro Brien. On scene law enforcement smelled alcohol and observed Ms. Moore appeared disoriented and had slurred speech."

Moore was transported to Grady Hospital. She declined a chemical test. Moore is charged with aggravated vehicular assault -a third-degree felony, aggravated vehicular assault -a fourth-degree felony, and two counts of operating a vehicle under the influence of alcohol or drugs – both first-degree misdemeanors.

Two other vehicles were involved in the crash. Those drivers sustained injuries ranging from back and neck pain to a broken toe and fractured vertebrae.

A Delaware County Grand Jury returned a seven-count indictment against Durbin after a disclosure of sexual misconduct was reported to Genoa Township Police.

SCOTT SPENCER SENTENCED

CHESS INSTRUCTOR INDICTED FOR SEXUAL MISCONDUCT



A Delaware County Grand Jury has returned a two-count indictment against F. Leon Wilson of Columbus.

Charges come after a report to law enforcement that a juvenile female had been touched inappropriately at her Lewis Center school.

Wilson was arrested April 23, 2015. He is in the Delaware County Jail on a \$500,000 municipal court bond.

"The investigation into Mr. Wilson is ongoing," said Delaware County Prosecutor Carol O'Brien. "He is a freelance instructor who

has taught chess at multiple daycare and educational facilities throughout central Ohio."

The Delaware County Sheriff's Office is asking parents to call (740) 833-2837 if their child indicates something uncomfortable or bad happened with Mr. Wilson. Parents are discouraged from interviewing their children, which can lead to disclosure of false information. The Sheriff's Office will provide trained experts to interview children in a non-threatening, sensitive, age-appropriate, and professional manner.

Wilson, 61, is charged with two counts of gross sexual imposition – both felonies of the third-degree. Both charges carry a school zone specification that could add time to a sentence.

An arraignment date for Wilson in common pleas court has not yet been set.
