### **ARMED ROBBER SENT TO PRISON**



***Dajae May***

Dajae May, age 19 of Dublin, was sentenced to 14-19.5 years in prison after being convicted by a jury in March. May was found guilty as charged of numerous violent offenses including Aggravated Robbery and Kidnapping. "Justice prevailed again in Delaware County. Another violent criminal will now go to prison because of the efforts of law enforcement and our office." Prosecutor Melissa Schiffel said.

In January of 2021, May and two others robbed a Verizon Wireless retail location located in Lewis Center. May and the other suspects had firearms on their person, and the victims were held at gunpoint and instructed to crawl into the inventory room as May and others collected over \$30,000 in iPhones.

### Court Update: April 11-15, 2022

- Ashley Quick was found guilty of criminal mischief after a jury trial. She was sentenced to 60 days in jail.
- Richard Zedekar pled guilty to forgery and receiving stolen property. Sentencing is set for 5/23/22.
- Masio Patterson pled guilty to non-support. Sentencing is set for 5/27/22.
- Dvontae Wright was sentenced to 11-15 years in prison for robbery and failure to comply.

### Court Update: April 18-29, 2022

- Dajae May was sentenced to 14-19.5 years in prison for kidnapping x2, aggravated robbery, having a weapon under disability, and receiving stolen property.
- Denver Roach was sentenced to a mandatory sentence of 60 months in prison for aggravated vehicular assault x2 and 12 months in prison for vehicular assault for a total sentence of 6 years (72 months) in prison.
- Mark Lairmore was sentenced to 30 months in prison for safecracking and breaking and entering.
- Antonio Bonney was sentenced to 24 months in prison for domestic violence.
- Travis Parsons was sentenced to a mandatory prison term of 36 months for aggravated vehicular assault x2.
- Donald Didion IV was sentenced to 5 years community control sanctions for disseminating matter harmful to juveniles x4 and importuning x2. As part of his sentence, he was sentenced to a community based correctional facility and ordered to spend 90 days in jail.
- Keira Smith was sentenced to 2 years community control sanctions for trespass in a habitation.
- Alex Rhodes was sentenced to 3 years community control sanctions with 35 days in jail for unlawful sexual conduct with a minor, compelling prostitution, and pandering.
- Samuel Sykes was sentenced to 18 months community control sanctions for receiving stolen property.
- Zachary Williams was sentenced to 18 months community control sanctions for disseminating matter harmful to juveniles.
- Breanna Morris was found guilty after a jury trial of receiving stolen property and was sentenced to 18 months community control sanctions.

- Evan Ciraky pled guilty to theft from a person in a protected class and identity fraud. Sentencing is set for 5/23/22.

- Deshawna Butler pled guilty to theft. Sentencing is set for 6/12/22.
