Sheriff's Office Seeks Help to ID Suspect in Sexual Assault Incident

Delaware County, OH – August, 2014

The Delaware County Sheriff's Office is asking for the public's help to identify a suspect in the Tuesday, Aug. 5th, sexual assault of a male victim at Highbanks Metro Park in Lewis Center.

The suspect is described as a middle-aged male, 5'11" tall, weighing 170 pounds. He has salt-and-pepper hair and a goatee with graying hair. The victim stated the suspect has a slight accent and is of Indian descent. He was wearing a white t-shirt with black vertical stripes and black running shorts when the incident occurred at 4:30 pm.

The suspect appears to be very familiar with this Park and its various trails.

DUBLIN WOMAN INDICTED FOR INSURANCE FRAUD

A Delaware County Grand Jury returned a 4-count indictment against Judith W. Cameron.

“Ms. Cameron is alleged to have forged a physician letter and physician statements in order to receive disability payments from American Fidelity Assurance Company,” said Delaware County Prosecutor Carol O’Brien. “The indictment against Ms. Cameron specifies the crimes occurring between May 18, 2009 through June 29, 2010.”

The Ohio Department of Insurance conducted the investigation.

Cameron, 50, is charged with theft – a fourth-degree felony, insurance fraud – a fourth-degree felony, telecommunications fraud – a third-degree felony, and forgery – a fourth-degree felony.

An arraignment date has not yet been set.

**DUO INDICTED ON MULTIPLE CHARGES
INCLUDING AGGRAVATED BURGLARY/ROBBERY**

A Delaware County Grand Jury returned a 7-count indictment against Emmie J. Lowery, of Delaware, and Shelvis A. Hairston, of Columbus.

The indictment comes after authorities responded to a robbery in progress call on August 2, 2014.

“When authorities reached the Lewis Center home of 80-year-old Rometta Everman, she reported an unknown male assailant had entered her garage after she pulled her vehicle inside,” said Delaware County Prosecutor Carol O’Brien. “Mrs. Everman said her purse, which included credit cards and cash, had been stolen.”

Video surveillance later showed a female using Mrs. Everman’s information to make purchases at a local gas station.

Emmie Lowery, 42, is charged with aggravated burglary (with a repeat violent offender specification) – a first-degree felony, robbery (with a repeat violent offender specification) – a second-degree felony, and 2 counts of identity fraud – both fifth-degree felonies.

Shelvis Hairston, 41, is charged with aggravated burglary – a first-degree felony, and robbery – a second-degree felony.

Both are in jail awaiting arraignment.

**MAN FOUND ALONE WITH MINOR AT
HIGHBANKS METRO PARK INDICTED AND JAILED**



Scott W. Spencer is in jail today after a Delaware County Grand Jury returned 2-count indictment against the 57-year-old Columbus man for unlawful sexual conduct with a minor.

Charges come as a result of a call to the Delaware County Sheriff's Office on August 15, 2014. A Park ranger made the call after finding Spencer alone with a juvenile female.

Scott W. Spencer "The victim in this case met Spencer online," said Delaware County Prosecutor Carol O'Brien. "Parents need to be vigilant in their efforts to find out what their children are doing online and who they may be corresponding with."

Spencer is charged with 2 counts of unlawful sexual conduct with a minor – both third-degree felonies.

Arraignment is not yet set.
