WOMAN GETS COMMUNITY CONTROL FOR FORGERY

Sabra Marie Williams pleaded guilty to four counts of forgery in June. Today, she was sentenced to three years community control.

Williams was indicted after a June 3, 2017 incident at the Tanger Outlet Mall.

“Law enforcement responded to the report of a suspicious person,” said Delaware County Prosecutor Carol O’Brien. “It was discovered that Williams had used fake credit cards to purchase products from various retailers including Victoria’s Secret, Nike, Gap, Skechers, Under Armour, and Polo Ralph Lauren.”

Williams, 26, was also ordered to pay \$207.71 in restitution and complete 40 hours of community service.

SENTENCING SET FOR OLD BAG OF NAILS ROBBER



Joseph Anthony Nappi, 34, will be sentenced on September 24, 2018 at 9 a.m.

Nappi entered an alford plea to robbery – a second-degree felony. An alford plea is where a defendant does not admit guilt, but rather, admits the evidence that would be presented against him would likely persuade a judge or jury to find the defendant guilty.

Nappi, a former Old Bag Of Nails employee, was charged after a January 8, 2018 call to Delaware Police that a white male in a ski mask had robbed the Old Bag of Nails Restaurant on Sandusky Street.

The call came in just after 9 a.m.

“An employee reported the masked robber approached him inside the restaurant before the start of business and demanded cash as well as the employee’s keys,” said Delaware County Prosecutor Carol O’Brien. “The masked man, who was wielding an aluminum baseball bat, got away with \$751 and the employee’s personal vehicle.”

The vehicle was later recovered three blocks away.

DELAWARE MAN CHARGED WITH THE RAPE OF TWO JUVENILES



A Delaware County Grand Jury has returned a 13-count indictment against 42-year-old David R. Morris of Delaware.

The indictment includes nine counts of rape – all first-degree felonies, two counts of gross sexual imposition – both third-degree felonies, one count of domestic violence – a fourth-degree felony, and one count of menacing by stalking – also a fourth-degree felony.

“In August 2018 a call came through to law enforcement alleging the sexual abuse of two young girls,” said Delaware County Prosecutor Carol O’Brien. “The girls, referred to as Jane and Mary Doe on the indictment, are both younger than 13 years of age.”

The indictment against Morris outlines the alleged crimes as occurring from June 1, 2017 through June 29, 2018.

Morris is in jail awaiting arraignment.

FIVE INDICTED FOR ONGOING THEFT AT CENTRAL OHIO HOME DEPOT STORES

A Delaware County Grand Jury has returned a 13-count indictment against 27-year-old Lindsey Clifford, of Columbus, 26-year-old Antonio Estrada, of Columbus, 47-year-old Donald Gorey, of Columbus, 38-year-old Shelley Hagerman, of Columbus, and 25-year-old Leanna Luna-Jimenez, of Hilliard.

The indictment against the group specifies the alleged criminal activity as occurring from June 1, 2018 through August 22, 2018.

"Surveillance video shows members of the group arriving at a Home Depot store together, but going inside separately," said Delaware County Prosecutor Carol O'Brien. "A cart would be filled with tools and taken past all points of sale."

The Home Depot stores targeted by the group include the Powell, Columbus, and Dublin locations.

"Not all members of the group participated in each instance of theft, but together the total in stolen merchandise is estimated to be at least \$50,000," O'Brien said. "It is likely that amount will increase, as each instance saw an estimated \$1,500 to \$5,000 in losses for the retailer."

The group allegedly committed more than twenty incidents of theft against Home Depot during the period of the indictment.

All members of the group are charged with one count of engaging in a pattern of corrupt activity – a second-degree felony, and additional prohibited activities – a third-degree felony. In addition, Clifford is charged with seven counts of theft – all fifth degree felonies, and robbery – a third-degree felony. Estrada is charged with four counts of theft – fifth-degree felonies. Gorey is charged with 10 counts of theft – fifth-degree felonies. Hagerman is charged with two counts of theft – both fifth-degree felonies. Jimenez is charged with six counts of theft – fifth-degree felonies, and one count of robbery – a third-degree felony.

Arraignment dates for the group are not yet set.
