LEWIS CENTER MAN SENTENCED FOR RAPE OF A MINOR

Justin Davidson, 25, is headed to prison for the rape and gross sexual imposition of a minor. He repeatedly sexually abused a young victim over the course of several years, and pled guilty to four counts of rape and one count of gross sexual imposition.

On July 28, Judge Gormley sentenced Davidson to a mandatory sentence of 10 years to life in prison. This sentence was mandatory under the law, based upon the facts of the case.

“We commend this victim for coming forward,” said Delaware County Prosecutor Melissa Schiffel. “This case reminds us how important it is to have those difficult conversations with our kids, to ask them how things are going in their lives, and to let them know they can tell us (or any trusted adult) if something is wrong or making them uncomfortable.”

POWELL MAN HEADED TO PRISON

Tony Fenstermaker, 53, was sentenced to eight years in prison for creating and possessing pictures and videos of a minor engaging in sexual activity, as well as for sexually abusing a minor.

An investigation began after self-recorded, explicit videos and images of Fenstermaker sexually abusing a minor were found on his personal computer.

Fenstermaker pled guilty in June to four counts of pandering sexually oriented material involving a minor and two counts of gross sexual imposition.

Judge Schuck sentenced Fenstermaker on August 9, 2021 to 8 years in prison plus 5 additional years post release control monitoring. As a result of his convictions, Fenstermaker is classified as a Tier II Sex Offender and will be required to register with the Sheriff in the county of his residence every 6 months for 25 years upon his release from prison.
