

## Court Update: November 27-December 1, 2023

-Kenneth Stapleton was sentenced to 5-7.5 years in prison for rape.

-Kawan Rawls was sentenced to 24 months in prison for domestic violence and violation of protection order.

-William Moore was sentenced to 6 months in prison for aggravated possession of drugs and possession of a fentanyl-related compound.

-Nicholas Wayt was sentenced to 15 days in jail and 5 years community control sanctions for vandalism. -Eric Brennan was sentenced to 3 years community control sanctions for domestic violence. As part of his sentence, he was ordered to spend time in a community based correctional facility.

-Thomas Helton was sentenced to 2.5 years community control sanctions for violation of protection order. -Karion Harman was sentenced to 2.5 years community control sanctions for aggravated possession of drugs.

-Kaysie Cumberledge was sentenced to 2 years and 3 months community control sanctions for aggravated possession of drugs.

-Joseph Petty was sentenced to 2 years community control sanctions for aggravated possession of drugs. As part of his sentence, he was ordered to spend time in a community based correctional facility.

## Court Update: December 4-29, 2023

-Donay Johnson was sentenced to 27 months in prison for failure to comply with an order or signal of a police officer, tampering with evidence, and possession of marihuana.

-Wesley Higgins was sentenced to 3 years community control sanctions for domestic violence. -David Hardman was sentenced to 3 years community control sanctions for telecommunications harassment and violation of a protection order.
