- Kenneth Peoples was sentenced to 10 years in prison for rape.
- Joseph Box was sentenced to 6-9 years in prison for kidnapping.
- Douglas Teneyck was sentenced to 5-7.5 years in prison for pandering obscenity involving a minor x5 and pandering sexually-oriented matter involving a minor x5.
- Tracy Jones was sentenced to 4-6 years in prison for felonious assault.
- Eric Johnson was sentenced to prison for 3-4.5 years for possession of heroin.
- Robert Block was sentenced to 10 months in prison for receiving stolen property.
- Russell Stevens was sentenced to 8 months in prison for aggravated possession of drugs.
- Oscar Del Angel was sentenced to 114 days in jail for domestic violence.
