

Court Update: May 22 – June 23, 2023

-Earle Nevel was found guilty after a jury trial of public indecency. Sentencing is set for 7/17/2023. -Eric Bellamy was sentenced to 28 years to life in prison for rape, gross sexual imposition, and menacing by stalking.

-Charles Patrick was sentenced to 60 months in prison for sexual battery.

-Vincent Rieger was sentenced to 3-4 1/2 years in prison for possession of heroin.

-Israel Starks was sentenced 45 months in prison for harassment with a bodily substance and violation of protection order.

-Peter Roy was sentenced to 36 months in prison for domestic violence and violation of protection order. -Ryan Acre was sentenced to 36 months in prison for identity fraud and forgery.

-Joseph Tuttle was sentenced to 30 months in prison for obstructing official business and failure to comply.

-Bradley Lampkins was sentenced to 24 months in prison for passing bad checks.

-Rustamzhon Mamakaziyev was sentenced to 1 year and 60 days in prison for operating a vehicle under the influence.

-Cody Hempy was sentenced to 12 months in prison for arson.

-Joshua Seely was sentenced to 9 months in prison for theft.

-John Hare was sentenced to 120 days in jail and 4 years of community control sanctions for failure to comply.

-Marcus Bradley was sentenced to 30 days in jail for aggravated possession of drugs.

-William Burbridge was sentenced to 20 days in jail for attempted identity fraud and forgery.

-Marico Talley was sentenced to 5 years community control sanctions for theft and robbery.

-Joshua Gregg was sentenced to 3 years community control sanctions for domestic violence.

-Cody L. Evans was sentenced to 3 years community control sanctions, with 60 days in jail, for trespass in a habitation and domestic violence.

-Eric Shackleford was sentenced to 3 years community control sanctions, with 100 days in jail, for operating a vehicle under the influence.

-Damarius Ransaw was sentenced to 3 years community control sanctions for aggravated possession of drugs.

-Brandon Daugherty was sentenced to 3 years community control sanctions for possession of a fentanyl related compound and aggravated possession of drugs.

-Kaitlin Schafer was sentenced to 3 years community control sanctions for possession of a fentanylrelated compound.

-Christopher Jenkins was sentenced to 2 ½ years community control sanctions for forgery.

-Darrien Hood was sentenced to 2 ½ years community control sanctions for attempted felonious assault.

-Cody Taylor was sentenced to 2 years community control sanctions for attempted theft and breaking and entering.

-Gannon Newbern was sentenced to 2 years community control sanctions for possession of marihuana. -Brian Mullins was sentenced to 2 years community control sanctions for possession of cocaine.
