TEAM JUSTICE WINS:

Today, after presentations from Prosecutor Melissa Schiffel and Chief Bruce Pijanowski with Delaware Police Department , Louis Pierce Jr. was denied parole by The Ohio Parole Board.

"I applaud the decision of The Parole Board in denying this serial rapist parole, said Delaware County Prosecutor Melissa Schiffel. "Delaware residents, parents, and community members can rest easy tonight knowing that at least this predator will remain behind bars. This is yet another example of what we can do when we support our Law Enforcement partners in pursuing justice. Thank you Chief Pijanowski for your continued dedication in keeping our community safe."

Case detail: Pierce was found guilty of raping two women and kidnapping a third. He was sentenced to 15-65 years in prison for his crimes. One of these victims was only 15 years old and on her way to school when Pierce put a knife in her side, kidnapped her, held her down in the snow and raped her at knife point.

Case updates, March 1-19:

-Matthew Schrader was found guilty of domestic violence after a jury trial and was sentenced to 36 months in prison.

- Willard Good was found guilty of domestic violence after a jury trial. Sentencing is set for 4/26/21.

-Kenneth Lewis was sentenced to 33 years in prison for aggravated robbery and kidnapping.

-Gary Will was sentenced to 14 years in prison for gross sexual imposition.

-Maleek Jackson was sentenced to 3 to 4.5 years in prison for engaging in a pattern of corrupt activity.

-Joshua Hodges was sentenced to 6 months in prison for ID fraud.

- Daniel Tormey was sentenced to 6 months in prison for breaking and entering, theft, and receiving stolen property.

-Philip Burkard was sentenced to 4 years community control for domestic violence.

-Jacob Likens was sentenced to 4 years community control for assault and burglary.

-Barkesha Sillah was sentenced to 18 months community control for assault for theft.

-Justin Rattleff was sentenced to 3 years community control for theft.

-Phalla Ly was sentenced to 5 years community control for non-support.

-Robert Clark II was sentenced to 3 years community control with 150 days in jail for trespass in a habitation and theft.

-Samantha Coleman was sentenced to 2 years community control for trespass in a habitation and theft.

From March 1-19, our Victim Service Unit handled 240 calls and/or emails referring to civil protection orders, violations, referrals, or safety planning.

Case updates, March 22-26:

-Marquis Vinson was sentenced to 33 months in prison for failure to comply, having a weapon while under disability, and vandalism.

-Kampfer Williamson was sentenced to 9 months in prison for domestic violence.

-Brian McCrum was sentenced to 4 years community control sanctions for felonious assault.

-Myanna Staysniak was sentenced to 2 years community control sanctions for telecommunications fraud and identity fraud.

-Mark Dennison pled guilty to breaking and entering. Sentencing is set for 5/3/21.

Our Victim Services Unit handled 70 phone calls and/or emails referring to civil protection orders, violations, referrals, or safety planning.
