- Deondry Little was sentenced to 5 years in prison for robbery with a gun specification and having a weapon under disability.
- Brandon Gartin was sentenced to 22 months in prison for aggravated possession of drugs and theft from a person in a protected class.
- Ismael Orduna was sentenced to 5 years community control sanctions for theft.
- Tarik Chukes Jr. was sentenced to 4 years community control sanctions for possession of a fentanyl-related compound.
- Matthew Rogers was sentenced to 3 years community control sanctions for abduction.
