Glen Goddard, 59, pleaded guilty today to multiple instances of theft by deception.

"Residents contracted with Goddard to finish their basements," said Delaware County Prosecuting Attorney, Carol O'Brien. "In each instance, Goddard collected money and did not complete the job."

Goddard pleaded guilty to three counts of theft – all fifth-degree felonies, and one count of theft – a fourth-degree felony.

Goddard is in jail. His bond is set at \$100,000. A sentencing hearing is set for December 8 at 10:15 am.

#### DUO INDICTED ON CHARGES OF BURGLARY/THEFT





A Delaware County Grand Jury returned a six-count indictment against two burglary suspects.

The Delaware County Sheriff's Office responded to a "burglary in progress" call at a Sunbury home on October 29, 2014 around 1:30 p.m.

"The suspects fled the home and were captured by authorities in a wooded area near Monkey Hollow Road several hours later," said Delaware County Prosecutor Carol O'Brien. "Several stolen items, including two shotguns and ammunition were recovered."

Shaun Diles, 31 of Cardington, and Kevin Smale, 28 of Mansfield, are each charged with burglary – a second-degree felony, two counts of theft – both third-degree felonies, theft – a fifth-degree felony, possessing criminal tools – a fifth-degree felony, and obstructing official business – a second-degree misdemeanor.

Diles and Smale are in jail awaiting arraignment.

# COLUMBUS MAN INDICTED ON MULTIPLE CHARGES OF RECEIVING STOLEN PROPERTY

A Delaware County Grand Jury returned a ten-count indictment against Harry Brice II.

The indictment comes after Westerville Police responded to a "theft in progress" call from the Polaris Parkway Meijer on September 15, 2014.

"Store employees reported a man attempting to use multiple credit cards to make gift card purchases," said Delaware County Prosecutor Carol O'Brien. "Authorities found that none of the cards swiped matched the numbers listed on the front of the cards."

Brice, 23, is charged with ten counts of receiving stolen property – all fifth-degree felonies. Each count specifies a different credit card.

An arraignment has not yet been set.

FORMER APARTMENT MANAGER SENTENCED TO COMMUNITY CONTROL

Alan Treese, 31, was sentenced to four years community control.

He was indicted in June 2014 for depositing multiple rent payments into his personal account. He had been the property manager for Silver Maple Apartments in Delaware from June 2013 through December 2013.

Mr. Treese pleaded guilty to theft - a fourth-degree felony and nine counts of forgery - all fifth-degree felonies on Oct. 13, 2014.

In addition to community control, Mr. Treese was ordered to pay restitution in the amount of \$9,554.
