



Court Update: October 30 – November 3, 2023

- Damion Hudson-Coleman was found guilty after a jury trial of gross sexual imposition.
- Robert Mayes II was sentenced to 12 months in prison for aggravated possession of drugs.
- Brooklynn Marino was sentenced to 24 months in prison for receiving stolen property.
- Jodi Capuano was sentenced to 3 years community control sanctions, with 26 days in jail, for aggravated possession of drugs. As part of her sentence, she was ordered to spend time in a community based correctional facility.
- Kampfer Williamson was sentenced to 3 years community control sanctions, with 14 days in jail, for domestic violence.
- Michael Damroze was sentenced to 2 years community control sanctions for telecommunications harassment.
- Daniel Akarri was sentenced to 2 years community control sanctions for strangulation.
- Dalton Theesfeld was sentenced to 2 years community control sanctions for possession of a fentanyl-related compound.
- Michael Damroze was sentenced to 2 years community control sanctions for telecommunications harassment.

Court Update: November 13-24, 2023

- Lucas Zickefoose was sentenced to 5-7.5 years in prison for robbery.
- Lloyd Mattox was sentenced to 5 years community control sanctions for nonsupport of dependents.
- Travis Summers was sentenced to 60 days in jail and 4 years community control sanctions for operating a vehicle under the influence and endangering children.
- Brandon Williams was sentenced to 3 years community control sanctions for possession of drugs and theft of drugs. As part of his sentence, he was ordered to spend time in a community based correctional facility.
- Logan Hoover was sentenced to 3 years community control sanctions for discharge of firearm on or near prohibited premises and improperly handling firearms in a motor vehicle.
- Alyna Camara was sentenced to 2 years community control sanctions for strangulation.
