

## Court Update: October 2 – 13, 2023

- Ricky Hess was found guilty of counterfeiting after a jury trial. Sentencing date to be determined.
- -Carlos Correa was sentenced to 8-12 years in prison for trafficking in cocaine.
- -Ryan Day was sentenced to 3-4.5 years in prison for aggravated possession of drugs.
- -Terry Barker was sentenced to 18 months in prison for having weapons while under disability.
- -Gary Hastler was sentenced to 12 months in prison for gross sexual imposition.
- -Jason Thompson was sentenced to 6 months in prison for aggravated possession of drugs and domestic violence.
- -Timothy Bell was sentenced to 6 months in prison for receiving stolen property and theft.
- -Devin Steele was sentenced to 5 years community control sanctions for theft. As part of his sentence, he was ordered to spend time in a community based correctional facility.
- -Gregory Rippel was sentenced to 4 years community control sanctions, with 120 days in jail, for pandering obscenity involving a minor or impaired person.
- -Dawn Powell was sentenced to 3 years community control sanctions for forgery and aggravated possession of drugs.
- -Justin Wade was sentenced to 3 years community control sanctions, with 14 days in jail, for grand theft.
- -Joey Smith was sentenced to 2.5 years community control sanctions, with 120 days in jail, for grand theft.
- -Robert Faulkner was sentenced to 2.5 years of community control sanctions for possession of a fentanylrelated compound and possession of cocaine. As part of his sentence, he was ordered to spend time in a community based correctional facility.
- -Holiday Morales was sentenced to 2.5 years community control sanctions for theft.
- -Elisee Vossah was sentenced to 2 years community control sanctions for attempted theft from a person in a protected class, theft from a person in a protected class, and ID fraud.
- -Bismark Mansaray was sentenced to 2 years community control sanctions for ID fraud, theft from a person in a protected class, and petty theft.
- -Mason Knodell was sentenced to 2 years community control sanctions for aggravated possession of drugs and tampering with evidence.
- -Jennifer Griggs was sentenced to 2 years community control sanctions for attempted tampering with evidence.
