

## Court Update: June 26-July 14, 2023

- -Larry Counts was sentenced to 17-22.5 years in prison for rape.
- -Jody Fox was sentenced to 8-12 years in prison for possession of cocaine with a firearm specification.
- -Andrew Mason was sentenced to 3-4.5 years in prison for aggravated possession of drugs.
- -Richard Gilbert was sentenced to 2-3.5 years in prison for corrupting another with drugs.
- -Russell Alston was sentenced to 36-48 months in prison for having a weapon under disability with a firearm specification.
- -Caleb Welch was sentenced to 36 months total in prison for 2 counts of domestic violence plus an additional 708 days for violation of post release control.
- -James Muddiman, Jr. was sentenced to 24 months in prison for passing bad checks.
- -Daniel Sims was sentenced to 16 months in prison for passing bad checks.
- -Cody Hempy was sentenced to 12 months in prison for arson.
- -Frank Lafferty was sentenced to 12 months in prison for theft.
- -Emmie Lowery was sentenced to 10 months in prison for theft.
- -Anna Morris was sentenced to 9 months in prison for possession of a fentanyl-related compound and possession of cocaine.
- -Justin Beck was sentenced to 3 years of community control sanctions for aggravated possession of drugs.
- -Hannah Smales was sentenced to 3 years community control sanctions for aggravated possession of drugs.
- -Jeffrey Bostic was sentenced to 3 years community control sanctions for theft. As part of his sentence, he was ordered to spend time in a community based correctional facility.
- Kelsey Sullivan was sentenced to 3 years community control sanctions for domestic violence.
- -Morrio Valentine was sentenced to 2.5 years community control sanctions for operating a vehicle under the influence.
- -Kory Brownlee was sentenced to 2 years community control sanctions for deception to obtain and theft.
- -David Hester was sentenced to 2 years community control sanctions for theft and breaking and entering.
- -Damonte White was sentenced to 2 years community control sanctions for having a weapon under disability.
- -Michael Morris was sentenced to 2 years community control sanctions for aggravated possession of drugs. As part of his sentence, he was ordered to spend time in a community based correctional facility.
- -Matthew Beougher was sentenced to 18 months community control sanctions for operating a vehicle under the influence.
