

Court Update: November 22-December 3, 2021

- After a jury trial, Enrique Mendez Gonzalez was found guilty of three counts of gross sexual imposition.
- -After a jury trial, Branden Davis was found guilty of Domestic Violence. Sentencing is set for 1/19/22.
- -Fred Parsons pled guilty to theft, breaking and entering, and failure to comply. Sentencing is set for 1/10/22.
- -Theresa Hutchinson was sentenced to 3 years community control sanctions for theft and possession of criminal tools.
- -Rodney Sharp was sentenced to 16 months in prison for Domestic Violence.
- -Brian Watkins was sentenced to 1 year in prison for Prohibited Acts Involving Titles.
- -Joshua Rowe pled guilty to robbery. Sentencing is set for 1/10/22.
- -Marc Ryder was sentenced to 5 years community control sanctions for theft.
- -Nicholas Marcum was sentenced to 3 years community control sanctions for three counts of pandering sexually oriented materials involving a minor, felonies of the fourth degree. He was earlier found to be a Tier II Sex Offender.
