



Court Update: August 29 – September 2, 2022

- William Barnes III was sentenced to 4-5.5 years in prison for improperly discharging a firearm.
- Merak Burr was sentenced to 30 months in prison for obstructing official business, failure to comply, and improper handling.
- Gary Caplinger was sentenced to 18 months in prison for theft and receiving stolen property.
- Anthony Linder was sentenced to 18 months in prison for domestic violence and obstructing official business.
- Robert Hubbard was sentenced to 9 months in prison for breaking and entering and theft.
- Dustin Fritz was sentenced to 6 months in prison for theft, receiving stolen property, and forgery.
- Joseph Box was sentenced to 180 days in jail for violation of protection order.
- Matthew Fleming was sentenced to 90 days in jail for aggravated possession of drugs.
- Anthony Gwinn was sentenced to 4 years community control sanctions for domestic violence.
- Tyisha Youngblood was sentenced to 3 years community control sanctions, with 90 days in jail, for robbery.

Court Update: September 6-30, 2022

- Brian K. Baldwin was sentenced to 16-19.5 years in prison for sexual battery x4 and pandering obscenities involving a minor x5.
- Sharma N. Coy was sentenced to 4 years in prison for theft from a protected class x3.
- Isaiah King was sentenced to 24 months in prison for operating a vehicle under the influence.
- Robert A. Ross was sentenced to 24 months in prison for failure to comply with order or signal of a police officer.
- Anthony Linder was sentenced to 18 months in prison for domestic violence and obstructing official business.
- Payton Dydek was sentenced to 3 years community control sanctions for attempted aggravated assault. As part of his sentence, he was ordered to spend time in a community-based correctional facility.
- Brian D. Goodman was sentenced to 3 years community control sanctions for forgery x7 and misuse of credit card.
- Christopher N. Britton was sentenced to 3 years community control sanctions for possession of drugs.
- Matthew L. Meadows was sentenced to 2.5 years community control sanctions for improperly handling a firearm in a motor vehicle.

- Andre L. Rogers was sentenced to 2 years community control sanctions for receiving stolen property.
