- Muata Fisher was sentenced to 5 life sentences without parole plus 80 years for rape x8 and gross sexual imposition x4.

- Melynda Loss was sentenced to 12 months in prison for grand theft of a motor vehicle and receiving stolen property x2.
- Ryan Burns was sentenced to 10 months in prison for receiving stolen property.
